In strict accordance with your requirements and specifications and the Michigan Department of Transportation specifications, or as specified below, we the undersigned, respectfully submit the following commitment for prices for the calendar year of 2021.

All prices to include loading and weighing and all other costs associated in the supplying of material. The contractor shall be responsible for providing scales and assume the cost of same. The cost for providing scales shall be reflected in the contract unit price. It shall be the contractor's responsibility to see that the scales are certified by the appropriate agency and that proof of certification is received by the Road Commission before starting their operation. The weigh person shall be provided by the Road Commission during the annual natural aggregate haul only. The contractor shall be responsible for providing loading of materials or assume the cost of same. The cost for providing loading shall be reflected in the contract unit price. Supplier shall commit to supply ALL required material.

It is understood that in addition to the major township natural aggregate haul, additional tonnages, of varying quantities, will be required throughout the year to be hauled by contract trucks and/or Road Commission trucks. All material is to be considered F.O.B and considered stockpile prices. All prices are based on net tons.

MUTUAL EXTENSION CLAUSE:

This bid, by mutual agreement of both parties, may be extended for a one-year or a two-year period, not to exceed a maximum of two additional years. The Road Commission has the right to reject a third year extension based on an unsatisfactory contractor evaluation. Jointly awarded bids will not be considered for extension. Requests for contract extensions must be in writing and received by the Road Commission no later than November 30th of each year.

RIGHT TO REJECT:

The Road Commission may award bids in whole or parts thereof, reserve the right to reject any and all proposals, waive irregularities in any bid and make award in any manner deemed in the best interest of the Road Commission.

ALL PROPOSALS MUST BE SIGNED BY A PERSON AUTHORIZED TO BIND THE COMPANY TO ITS CONTENTS. THIS PROPOSAL IS BINDING ON THE COMPANY SUBMITTING THE PROPOSAL FOR A PERIOD OF 30 DAYS AFTER THE DUE DATE FOR SUBMISSIONS AND MAY NOT BE WITHDRAWN FOR ANY REASON DURING SUCH 30 DAY PERIOD. IN THE EVENT A COMPANY SUBMITTING A PROPOSAL ATTEMPTS TO WITHDRAW IT DURING THE 30 DAY PERIOD AND WOULD BE THE SUCCESSFUL BIDDER OR IF A COMPANY REFUSES TO HONOR ITS BID AFTER AWARD BY THE ROAD COMMISSION, IN SUCH EVENT, THE COMPANY WILL BE RESPONSIBLE FOR ANY INCREASED COST INCURRED BY THE ROAD COMMISSION DUE TO REBIDDING OR AN AWARD AT A HIGHER PRICE. IF PROVIDED, ROAD COMMISSION PROPOSAL FORMS MUST BE USED. ANY ALTERATIONS TO THIS FORM WILL RENDER THE PROPOSAL VOID. IF ADDITIONAL OR CHANGED INFORMATION IS NEEDED, IT MUST BE DONE USING AN ATTACHED SHEET AND MARKED AS SUCH.
