RESOLUTION NO. 23-01, MDOT CONTRACT, HIP-CRRSAA:

Commissioner Lauwers inquired about the funding under the contract. Director Hazelton explained it has been used for the Large Culvert Replacement Program. On a motion by Commissioner Ward seconded by Commissioner Lauwers Resolution No. 23-01, for Contract No. 2023-0052 between the Board of County Road Commissioners of the County of St. Clair and the Michigan Department of Transportation for funding of Highway Infrastructure

Programs under the Coronavirus Response and Relief Supplemental Appropriations Act, be approved. Motion carried 3-0. (See exhibit at close of minutes.)

- Phantom 4 R2K Drone from Noar Technologies for \$4,123.16 Motion carried 3-0.
