On a motion by Commissioner Lauwers seconded by Commissioner Ward contracts for Supplemental Bridge Inspections Consultant services in 2024 be awarded to both Great Lakes Engineering and the Spicer Group as recommended. Motion carried 3-0.

Ms. Holzberger reviewed the main points of the draft 2024 Road Commission budget. Commissioner Ward inquired about the Krafft Road project. Director Hazelton provided maps showing projects scheduled for 2024.
