Lifting lugs to manufacturer's specifications shall be included on all tubes of 42" or equivalent low arch pipe or larger.

Each shipment shall include a Mill Analysis Certification matching all metal used in that shipment.

Any damaged galvanization shall be treated per state specifications.

IN THE EVENT A COMPANY SUBMITTING A PROPOSAL ATTEMPTS TO WITHDRAW IT DURING THE 30 DAY PERIOD AND WOULD BE THE SUCCESSFUL BIDDER OR IF A COMPANY REFUSES TO HONOR ITS BID AFTER AWARD BY THE ROAD COMMISSION, IN SUCH EVENT, THE COMPANY WILL BE RESPONSIBLE FOR ANY INCREASED COST INCURRED BY THE ROAD COMMISSION DUE TO REBIDDING OR AN AWARD AT A HIGHER PRICE.
