CAPITAL OUTLAY:

On a motion by Commissioner Ward seconded by Commissioner Lauwers the approval of First Response Roofing to provide four new windows and a new roof on the chloride building at the Capac Warehouse. Motion carried 3-0.

CONSULTING SERVICES – ASBESTOS SURVEY – OFFICE BUILDING:

On a motion by Commissioner Lauwers seconded by Commissioner Ward the contract bid for the asbestos survey be awarded to Intertek-PSI. Motion carried 3-0.

BURTCH ROAD AND GRISWOLD ROAD BID:

On a motion by Commissioner Ward seconded by Commissioner Lauwers the contract bid for Burtch Road and Griswold Road be awarded to Ace-Saginaw Paving Co. Motion carried 3-0.

MISCELLANEOUS BUSINESS:

Director Hazelton reported that the Rabidue Road settlement should be arriving soon. Both parties agreed to the settlement. It was noted by the Road Commission insurance pool attorney, that the Road Commission crews kept good records. Director Hazelton reported on the possibility of having a company in Sandusky rebuild the engine on a 2008 Capac truck. There would be a short turn around having this company rebuild the engine. Director Hazelton noted the possibility of acquiring a military surplus truck that became available.

The rough estimate is between \$12,000 and \$15,000 plus shipping and freight. Truck could be used for parts, or to be added to the fleet. Director Hazelton noted that all options are being explored regarding the minimum salt purchase requirement. Director Hazelton also reported that two new trucks from 2023's capital outlay budget have now been delivered. Director Hazelton also noted that a possible union tentative agreement might be reached with the Production Union.

Commissioner Lauwers commended the District Foreman for all their hard work, and for the relationships that they have established with the townships. Commissioner Lauwers noted that the prices of used trucks have come down, before having the engine rebuilt, Road Commission should check what a new one would cost. Director Hazelton will explore all possibilities. Commissioner Lauwers would like the possibility of having DEF bid next year, as it is an ever increasing cost and required for most vehicles at the Road Commission.

ADJOURN:

There being no further business to come before the Board, it was moved by Commissioner Ward seconded by Chairman Lauwers to adjourn the meeting at 8:50 am. Motion carried 3-0.
